Background:

Logistics firms, which are involved in the movement, storage, and flow of goods, have been directly affected by the COVID-19 pandemic. Some of the logistic company has lost an estimated R4-billion in revenue and R1-billion in operating profit during the peak lockdown period of March to May.

In Southern Africa, the pandemic has impacted several logistics companies, with only 50% of staff operational, have been able to make barely 60% of its forecast revenue during quarter one. In June, some company was operating with only 60% port staff. This forced some exporters to transport goods hundreds of kilometres away or risk millions in lost revenue as well as severe damage.

Currently, operational, strikes and protests with trucks and buses being burned as well as an increase in hijacking and theft as unemployed people get increasingly desperate. There is a massive headache with no end in sight in Logistics, fleets and transportation industries.

Transport operators and logistics providers are cutting staff while many truckers are reducing the size of their fleets to counter the loss of business. But for some even these actions are insufficient to save logistics industries. These tough times are providing major challenges to all involved in the transport and logistics industries, but the situation is also resulting in plenty of out-of-the-box thinking by management and operational teams to ensure the viability and sustainability of their businesses. The financial impact on local supply-chain markets is still unknown.

Therefore this summit is designed for the CEO's, Directors, Executive, Managers, Fleet Managers and entire supply chains within the Logistics and Transportation sectors and it will provides the attendees with a unique, dynamic and safe space to discuss challenges with their peers and find a strategic solution to achieve their goal.
